MINIMUM SPENDING

*All Memberships require Minimum Spending
Minimum Spending is calculated on food and beverages purchases only, per calendar quarter (excluding service charge and tax or any additional tipping).*

SERVICE CHARGE

A service charge of 20% shall be calculated on all food and beverage purchases, 15% of which will go to the server as a gratuity.

INDIVIDUAL GOLF FEES

A Golfing Member or Family Member who is eligible to use the practice facilities and golf. All golfing members are required to pay a Golf Package, Buyers Club and Hole in One fund.

GOLF PACKAGE

For members and spouses, this fee provides for Shoe Club, GHIN Handicap and Practice facilities in accordance with the Golf Rules and Regulations. Buyers Club – Discounted Golf Merchandise.

EMPLOYEE CHRISTMAS FUND

Annually each member's November statement will include a charge of \$25.00 for the Employee Christmas Fund. Voluntary additional contributions to this fund are also accepted. All Membership classifications pay the Christmas fund.

HOLE IN ONE

Golfing members are automatically enrolled in the Hole-in-One Club. Each member making a hole-in-one witnessed by another golfing member during an official round and verified by the Golf Professional shall receive an award consisting of one-half merchandise in the Pro Shop and one-half cash credit to the member's account. The cash award is intended to off-set the cost of drinks in the men's lounge and grill room (for ladies) on the day of the hole-in-one. As soon as the ace is verified, tabs will be opened on the member's account in the men's lounge and grill room (for ladies) and each golfing member present shall be entitled to one drink. A charge of \$5.00 shall be applied to the account of each golfing member periodically as needed to replenish the fund.

SWIMMING FACILITIES

*Olympic pool: Heated, L-shaped, 75 feet x 50 feet, Wading pool: Round, 18 feet in diameter
Teen Room: Concession Stand and Fire Place, Locker and dressing rooms*

CLUB HOUSE FACILITIES

Clubhouse: *40,000 square feet, designed by Joseph Schuster, Architect. Interior design by Francis Lux.*

Main Dining Room: *Accommodates up to 250 persons and offers spectacular golf course view. Separated from the main Lounge, full service bar and dance floor by an open fireplace. By reservations only.*

Grill Room: *Full service bar and informal dining for up to 75 persons. Large screen television.*

Outside Patio: *for dining, weather permitting*

Private Dining Rooms: *Parlor A (up to 14 persons) and Parlor B (up to 14 persons) are available to members for business meetings and private dining. By reservation only.*

Enclosed Patio Room: *Accommodates up to 100 persons for meetings or private functions. Enclosed with a bar and dance floor overlooking the pool and golf course. By reservation only.*

Spouse and any children under the age of 22.

A Member's guest must be accompanied by a member over the age of 18. A guest will be charged \$10.00 per guest per day. A guest is limited to six(6) times per season. Out of town guests are exempt from this maximum. And a member may request a week pass for out of town guests for a fee of \$50.00 per person by registering in the office

**SILVER MEMBERSHIP AGREEMENT
LIMITED MEMBERSHIP
One Year Contact DATE**

I _____ do hereby agree to join Ohio Prestwick Country Club as a Full Member - Silver Classification. This membership initiates with a yearly fee of \$399.00, plus sales tax, which provides access to the Driving Range, a GHLN Handicap, Shoe Club and Buyers Club (discount on merchandise)

Additionally, dues for this membership are \$99.00 per month, for 12 months beginning the date membership approved. I understand that this is a binding one year commitment and should I choose to leave the club within the first year, for any reason I owe and will be billed for any unpaid monthly dues. This is a family membership. Family includes member, spouse and children under the age of 22. Children over age 22 will be considered a guest or may purchase their own membership at the prevailing rates at that point in time. This Silver Membership allows for privileges at all dining facilities within the club and access to private rooms for personal functions with no room rental fees. However, all food and beverage must be purchased through the club. Membership also includes Swimming Pool access from Memorial Day to Labor Day and golf, year-round, when weather permits. Swim Privileges included for Member, Spouse and any children fewer than 22 and \$10.00 per guest. Cart fees will be \$22.00 per person per round. You are welcome to bring guests to play golf, understanding that they will be billed at current guest rates: 18 holes weekdays - \$45.00, 18 holes weekends and holidays - \$50.00, 9 holes - \$25.00. Membership allows you to play in all club tournaments for the cost of the event, plus cart fee. There is a minimum spending requirement of \$225.00 on food and beverage only, not to include service charges or sales tax. This is a quarterly requirement and is in effect for all four quarters of the year. Any difference between the minimum spending requirement and the amount actually spent on food and beverage will be charged to member's account at the end of each quarter.

When any club member has a hole-in-one which is witnessed and then verified by a golf professional, each golfing member will have \$5.00 charged to their account. A bar tab is opened after the hole-in-one is verified, allowing each golfing member to have a drink on member's account. The member making the hole-in-one receives one half of the fund in credit for pro-shop merchandise and one half in credits toward his account. The credit award on his account is intended to offset the cost of the tab. annually, in November, each member's account will be charged \$25.00 for the Employee Christmas Fund.

I understand that in the first week of each month I will receive a monthly statement with all charges incurred for the previous month, plus pre-monthly dues. The entire balance will be due by the 15th of the month.

If payment is not received by this date, member's credit card will be charged. A recurring billing contract is attached for your credit card information which will be kept in a secure place. A 1.5% finance charge will be added to accounts that are not paid by the 30th of each month.

I agree to be a member in good standing for one year. After the first years commitment is satisfied, I may rejoin for a second year at a rate of \$129.00 per month, plus sales tax. All of the above fees will also be applied. If for any reason I would like to resign after my one year commitment, I may do so by advising the club of my intentions in writing.
